2 Programmes: COOCK and TETRA

COOCK – Aim of programme

- ► Collective research with focus on knowledge building/expansion
- Accelerating the introduction of technology and knowledge at SME's by carrying out cases in order to evaluate the value of a technology or specific knowledge in a business context
- ▶ 'Collective' and focus on a broad, but clearly defined target group of non-R&D intensive companies with an emphasis on SMEs that will implement the project results (after the end of the project)
- Supervised by a user group made up of representatives of the target group
- Sufficiently high ambition level with regard to the broader dissemination of knowledge to the total target group of companies
- All technologies and applications are eligible, aiming at an economical valorisation and resulting in new or improved products and/or processes
- Projects that are focusing on the primary sector only are not eligible

Funding Conditions

- Percentage of funding: 60 %
- 40 % is co-financed (by e.g. company contributions)

Eligible organisations:

Flemish research and knowledge-dissemination organisations

TETRA – Aim of Programme

- ➤ Stimulate transfer of technological and scientific knowledge to a large group of SMEs with the purpose of using this knowledge at the end of the project
- All technologies and applications are eligible, aiming at an economical valorisation and resulting in new or improved products and/or processes
- Projects that are focusing on the primary sector only are not eligible. Encouraging the implementation of R&D results via the set-up of user committee of stakeholders. Increasing cooperation between SMEs and Flemish Institutes of higher education (University Colleges and Universities)
- ▶ Dissemination of the results, especially via 'valorisation activities' with the user committee and via educational programmes of University Colleges and Universities reaching a broad group of SME's
- Results are open for all companies in Europe (transfer cf. European legislation without exclusivity rights after finishing the project)

Funding Conditions

- Percentage of funding: 92,5 %
- > 7,5 % is financed by involved companies in user committee

Requirements

Eligible organisations:

► Main applicant is Flemish University College or University
